
# FHA - Our Complexity



### **Clinical Use Cases**

**Example #1:** A home health worker checks if a client has been admitted to hospital, prior to making a home visit

**Example #2:** An ER clinician reads a patient's mental health history (typically part of a case file in PARIS) to support clinical decision making at the point of care

**Example #3:** Home and mental health workers access acute care records to support follow up and continued care planning

# **UCI Project Overview**

#### Clinical requirement:

- Information in different FH clinical systems must be available to support clinical decision making, and tightly integrated into clinical workflow
- The UCI project is delivering the FHA health information exchange solution to achieve this

#### Opportunity:


 To leverage the provincial Health Information Access Layer (HIAL) and Provincial Lab Information System (PLIS) to extend the data available to FHA clinicians in Meditech and Paris point of service systems




# **UCI History**


- Long standing, strategic requirement for FHA clinicians
- Allscripts dbMotion selected via RFP as Health Information Exchange (HIE) solution
- Ministry of Health request for FH to lead lower mainland discussions re HIE
  - Involved MoH, FH, Provincial Health Services Authority









# **Project Status**

- Phase 1A: Meditech data available to PARIS users:
  - Connectivity to the MoH EMPI for Patient Centric Provincial Identification: COMPLETE
  - Roll-out to PARIS users: COMPLETE
  - Support and training to users: COMPLETE
- Phase 1B: PARIS data available to Meditech users:
  - Environment and message mapping: COMPLETE
  - Clinical functional testing: June 2015
  - Roll-out to Meditech users: July 2015
- Phase Two: PARIS and Meditech users viewing PLIS data
  - Connectivity to PLIS test: COMPLETE
  - Middleware design/development: COMPLETE
  - Testing: May/June 2015
  - Roll-out: July 2015

### **Lessons Learned**

- Support from all levels of leadership
  - Executive and clinical
- Stakeholder management
  - Importance of setting up an escalation forum with all vendors/stakeholders present
  - Clinical working group essential to assist in key decision making
- Resources (internal and external)
  - Defined project roles with assigned responsibility for project components
  - Required more resources than initially anticipated
- Competing initiatives
  - Source system upgrades
  - Dependency upon Person Identity Project



### **Lessons Learned...**

- Complexity of integration initiatives
  - Environment set up and reliance upon third party vendor
  - Reliance upon Ministry of Health (EMPI)
  - Source systems interconnected with UCI upgrades/changes
  - Data mapping/integrity fixing source system data issues
  - Conformance standards (PLIS)
- Communication
  - Understand and target communication based upon user groups
- Timeline and expectation management
  - It will take longer than you expect...



### **Lessons Learned...**

- Operational support
  - Transition to support is challenging without appropriate training, documentation and resources
    - Working with dbMotion support tools
- Training of implementation and support staff on entire solution
  - Vocab mapping, system architecture



# **Next Steps**

- Expand dbMotion platform
  - Upgrade to latest version
  - Collaborate
  - Agent
- Connect with additional internal systems
  - As identified and prioritized by the UCI Clinical Working Group

- Connect with additional external systems
  - Provincial repositories (Panorama, Pharmanet, PDIV)
  - Other HA repositories
  - As identified and prioritized by the UCI Clinical Working Group
- Make FH data available to external stakeholders
